- Support the work of relevant Working Groups of Eurosmart: briefings; general administrative support and event management;
- Support in external and digital communication (website update and social networks management);

## Skills/Qualifications

- Master's degree in political science / law / economy with a decent grasp of EU politics. Experience working in or with EU institutions would be an advantage.
- An experience with advocacy campaigning and/or policy analysis, and/or demonstrate influencing skills and strong strategic and political understanding.
- Good research, analytical skills and ability to critically review and very strong written communication skills.
- Demonstrate a high level of initiative. Be positive and good team player, organised, and stress resilient. You prioritise achieving outcomes over running activities.
- Be able to quickly familiarise with technical IT new topic through self-led research.
- Proficiency in English language; additional languages, such as French and/or German is an asset.
